ORDER:-

In the Government order third read above, the Government declared its intention to specify the area comprising in Nelliyalam Second Grade Municipality to be a local planning area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) and the same was published with the Housing and Urban Development Department Notification No.II (2)/HOU/20/2016 at page 10 of Part-II Section 2 of the Tamil Nadu Government Gazette, dated the 13th January, 2016 and also in the Nilgiris District Gazette, dated the 1st May, 2016.

2. In the letter fourth read above, the Commissioner of Town and Country Planning(i/c) has stated that objections and suggestions were not received from the public in this matter and has requested for confirmation of Notification under sub-section (4) of section 10 of the said Act.
