ORDER:

In the Government Order first read above, the Gummidipoondi Local Planning Area was constituted.

2. In Government Order second read above, Gummidipoondi Local Planning Area was declared as local planning area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act 1971 (Tamil Nadu Act 35 of 1972).

3. In the Government order third read above, the Government notified its intention to include additional areas covered under the Gummidipoondi Local Planning Area and the same was published in notification No.II(2)/HOU/818/2016 at pages 715-716 of Part-II Section 2 of the Tamil Nadu Government Gazette, dated the 14th December, 2016 and also in the Thiruvallur District Gazette, dated the 1st July, 2018 for general information as required under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

4. In the letter fourth read above, the Director of Town and Country Planning has stated that objections and suggestions were not received from the public in this matter and he has requested for confirmation of Notification under sub-section (4) of section 10 of the said Act.

5. The Government, after careful examination, accept the proposal of the Director of Town and Country Planning in para 3 above. Accordingly, the Government declares the area specified in the Notification appended to this order, to be the Gummidipoondi Local Planning Area.

6. The appended Notification will be published in the next issue of Tamil Nadu Government Gazette.
