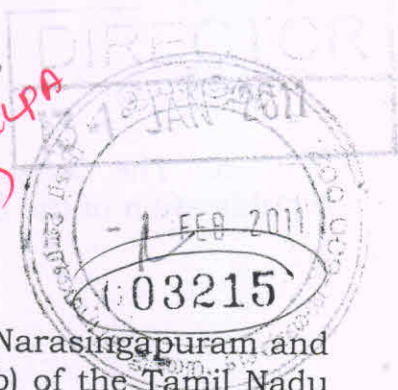

**ORDER:-**

The Director of Town and Country Planning, in his letter third read above has stated that Attur and Narasingapuram are twin towns abutting each other and Master Plan for Attur has already been prepared and review approved and as it is not viable for two urban nodes adjacent to each other, it has been suggested that Attur may be added with Narasingapuram and 8 revenue villages to form a composite local planning authority under section 10(1) of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) so as to prepare a comprehensive development plan including the proposal of road network and ring roads etc. He has also furnished the details regarding area and population.

2. The Government, after careful examination of the proposal of the Director of Town and Country Planning, have decided to declare the intention of the Government to include Narasingapuram and its environs in the Attur Local Planning Area. The appended notification will be published in the Tamil Nadu Government Gazette.

3. The Collector of Salem District is directed to republish the Notification in the District Gazette.

4. The Director of Translation, Chennai- 600 009, is directed to arrange to have the Notification, translated into Tamil and to forward the translation urgently to the Collector of Salem District under intimation to the Government.
