ORDER:

In the Government Order first read above, the Government has declared the intention to include some additional areas in the Kancheepuram local planning area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. The Member Secretary, Kancheepuram local planning authority stated that, it has also been proposed to add villages of Anjure and Veerambadi areas to the said local planning area and that objections and suggestions have not been received from the public in this matter.

3. The Commissioner of Town and Country Planning has therefore requested the Government to add the above said villages to the Kancheepuram local planning area under clause (b) of sub-section (1) of section 10 of the said Act.

4. The Government, after careful examination, accept the proposal of the Commissioner of Town and Country Planning in para 3 above. Accordingly the appended Notification will be published in English in the Tamil Nadu Government Gazette and republished in English and in Tamil in the Kancheepuram District Gazette.

5. The Collector of Kancheepuram District is requested to republish the Notification in the District Gazette.

6. The Commissioner of Translation, Chennai, is requested to arrange to have the Notification translated into Tamil Version and forward the same urgently to the Collector of Kancheepuram District.

7. The Collector of Kancheepuram District is directed to report to Government the date of republication of the Notification in the District Gazette.

NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) and in supersession of the Housing and Urban Development Department Notification No.II(2)/HOU/61/2012, published at pages 42 and 43 of Part-II Section 2 of the Tamil Nadu Government Gazette, dated the 25th January 2012, the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Kancheepuram local planning area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II (2)/RUL/ 4632/74, published at pages 556 and 557 of Part II - Section 2 of the Tamil Nadu Government Gazette, dated the 6th November 1974.

2. Notice is hereby given that the draft amendment will be taken into consideration under clause (b) of sub-section (1) of section 10 of the said Act, on or after the expiry of two months from the date of publication of this Notification in the Tamil Nadu Government Gazette, and that any objection or suggestion, which may be received from any inhabitant or any local authority or institution in the said local areas, with respect thereto, before the expiry of the period aforesaid will be duly considered by the Government of Tamil Nadu. 
