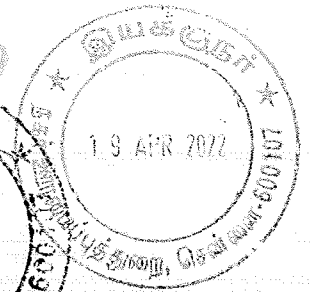
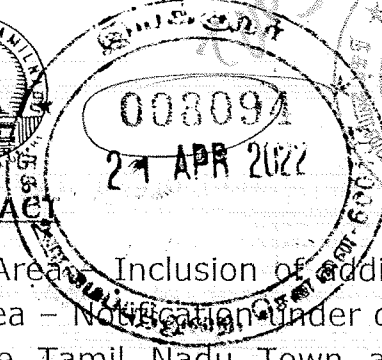

In the Government Order first read above, Sathyamangalam local planning area was declared under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government Order second read above, the Government have issued orders to accord Administrative Sanction for preparation of Master Plan for 75 towns.

3. In the letter third read above, the Director of Town and Country Planning has requested the Government to add additional areas in the said Sathyamangalam local planning area under clause (b) of sub-section (1) of section 10 of the said Act.

4. The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to specify the areas mentioned in the notification appended to the order as Sathyamangalam local planning area under clause (b) of sub-section (1) of section 10 of the said Act.
