**ORDER:**

During the Demand Session 2021-2022, while moving Demand No.26, the Hon'ble Minister (Housing and Urban Development) has made the following announcement on the floor of the Legislative Assembly:

"There is no Master Plan to the Areas Sholinghur, Vadalur, Thirukoilur and Gudalur, Nilgiris District. To protect natural resources, its antiquity and to ensure planned development Master Plans will be prepared".

2. In the letter read above, the Director of Town and Country Planning has stated the first step in preparation of Master Plan for Gudalur Local Area comprising in Gudalur Municipality have to be declared as Gudalur Local Planning Area under section 10(1)(b) of Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972). Hence, he has requested the Government to declare the Local Area comprising in Gudalur Municipality to be a Gudalur Local Planning Area.

3. The Government after careful consideration of the above proposal of the Director of Town and Country Planning, have decided to declare their intention to declare the areas specified in the notification appended to this order as Gudalur Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Tamil Nadu Act 35 of 1972.

4. The appended Notification will be published in English in the Tamil Nadu Government Gazette and republished in English and in Tamil in the Nilgiris District Gazette.

5. The Collector of the Nilgiris District is directed to republish the Notification in the District Gazette.

6. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of the Nilgiris District under intimation to the Government.

7. The Collector of the Nilgiris District is directed to report to Government the date of republication of the Notification in the District Gazette.
