ORDER:

In the Government Order first read above, the Government have notified 12 Regional Planning Areas under section 10(5) of the Tamil Nadu Town and Country Planning Act, 1971. In pursuant of that the Directorate of Town and Country Planning is preparing the Regional Plans for 10 Regional Plan Areas (excluding CMA Region).

2. In the Government Order second read above, the Government issued orders for appointing the School of Planning and Architecture, Bhopal for the preparation of Regional Plans for Coimbatore and the Nilgiris regions covering an extent of 18,244 Sq.km at a cost of Rs.2,75,11,050/- on nomination basis under clause (b) of section 16 of Tamil Nadu Transparency in Tenders Act, 1998.

3. In the Government Order third read above, the Government have sanctioned an amount of Rs.41,63,59,224/- from the Local Planning Authority Fund for preparation of 8 regional plans for a total extent of

98,013 sq.km. The Government have framed the Regional Plan (Preparation, Publication and Sanction) Rules, 2021 vide G.O.(Ms.)No.2, Housing and Urban Development Department, dated 10.01.2022.

4. In the letter fourth read above, the Director of Town and Country Planning among others has requested that the School of Architecture and Planning, Anna University and Indian Institute of Technology, Khargapur have submitted their Expression of Interest for the preparation of Salem and Sivagangai regional plans respectively.
