2. The appended Notification will be published in the next issue of the Tamil Nadu Government Gazette.

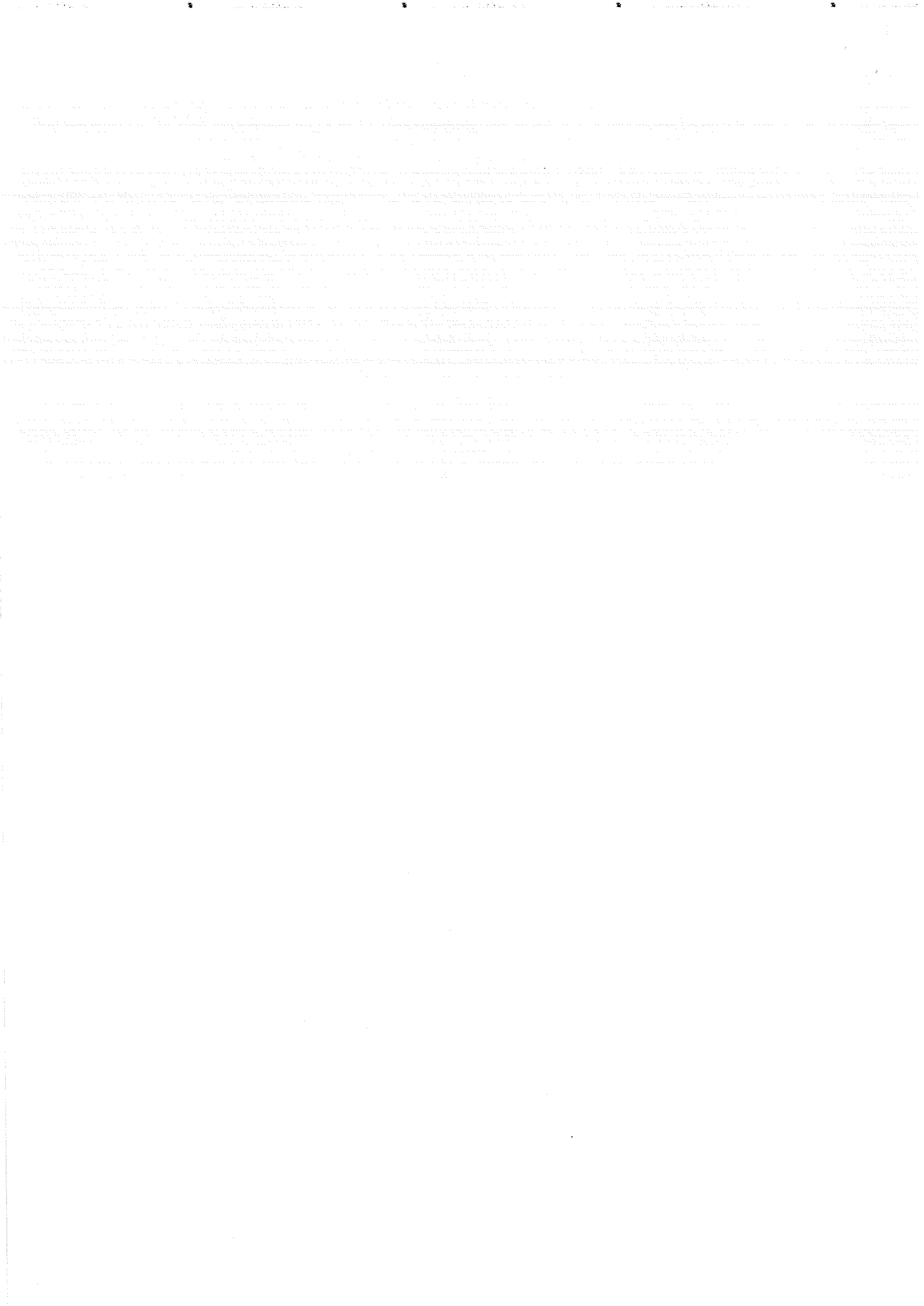
