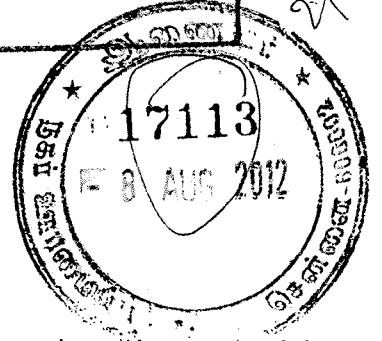

ORDER:

In the Government Order first read above, Government declared its intention to specify the area comprised in Odanchatram Municipality to be a local planning area and it was published at page 465 of Part - II Section 2 of the Tamil Nadu Government Gazette dated the 7th November 2007 for general information as required under sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. The Director of Town and Country Planning has stated that no objections and suggestions have been received from the public in this matter. He has also stated that in the Government Order third read above, the Odanchatram Special Grade Town Panchayat has been upgraded as Second Grade Municipality and has requested to declare Odanchatram Local Planning Area under section 10(4) of the Tamil Nadu Town and Country Planning Act, 1971.

3. The Government, after careful consideration, accept the proposal of the Director of Town and Country Planning in paragraph 2 above, and declare the area

specified in the Notification appended to this order, to be the Odanchatram local planning area.

4. The appended Notification will be published in the next issue of Tamil Nadu Government Gazette.




