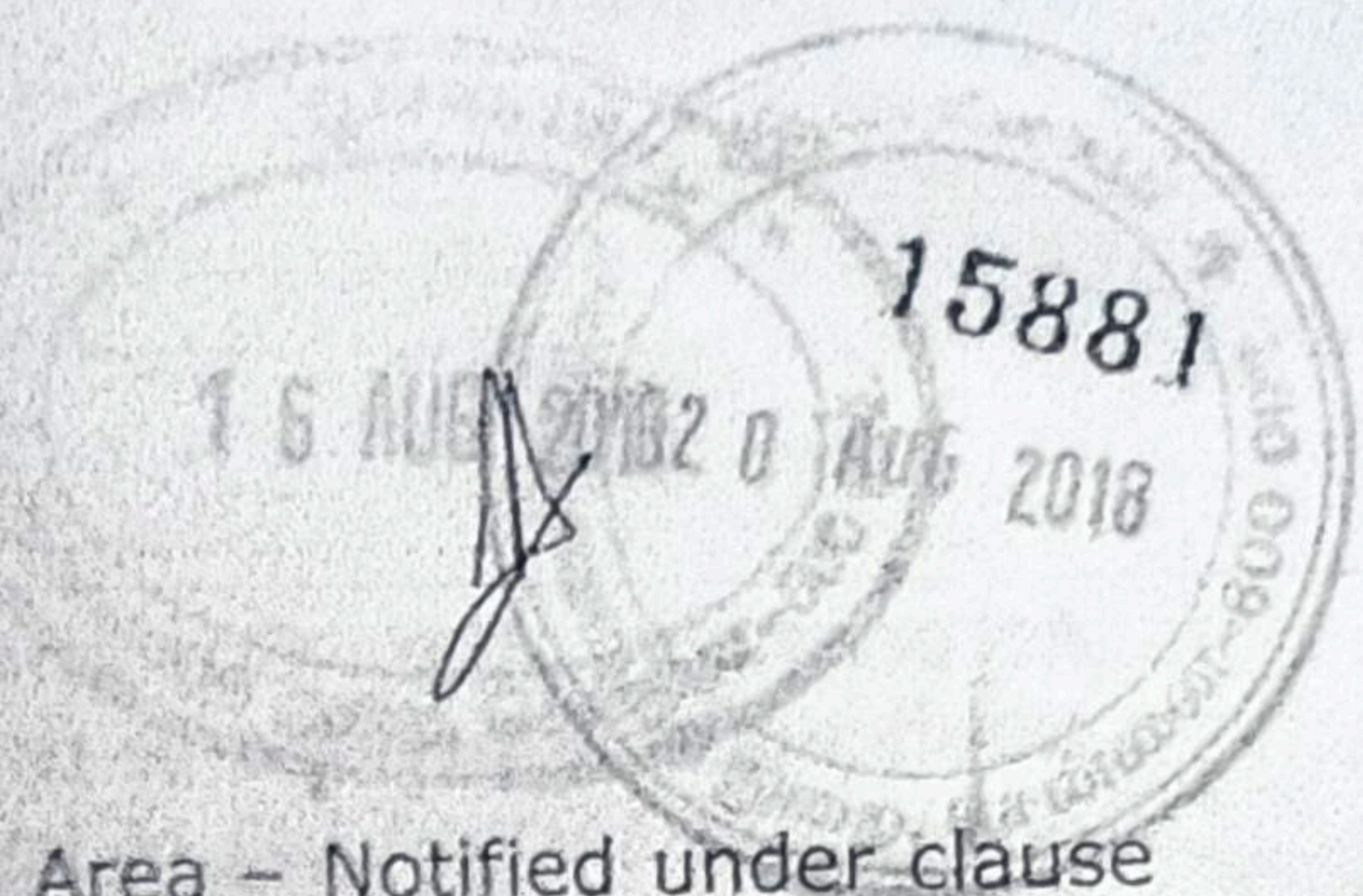

**ORDER:**

In the Government order first read above, the Government declared its intention to specify the area comprising Keeranur Selection Grade Town Panchayat to be a local planning area under clause (b) of sub-section(1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971(Tamil Nadu Act of 35 of 1972) and the same was published in the Housing and Urban Development Department Notification No.II(2)/HOU/1011/2017 at pages 947 and 948 of Part-II - Section 2 of the Tamil Nadu Government Gazette, dated the 13<sup>th</sup> December 2017 and also in the Pudukottai District Gazette, dated the 14<sup>th</sup> May 2018.

2. In the letter second read above, the Commissioner of Town and Country Planning has stated that no objections and suggestions have been received from the public in this matter and has requested for confirmation of Notification under sub-section (4) of section 10 of the said Act.

3. The Government, after careful examination, have decided to accept the proposal of the Commissioner of Town and Country Planning.
