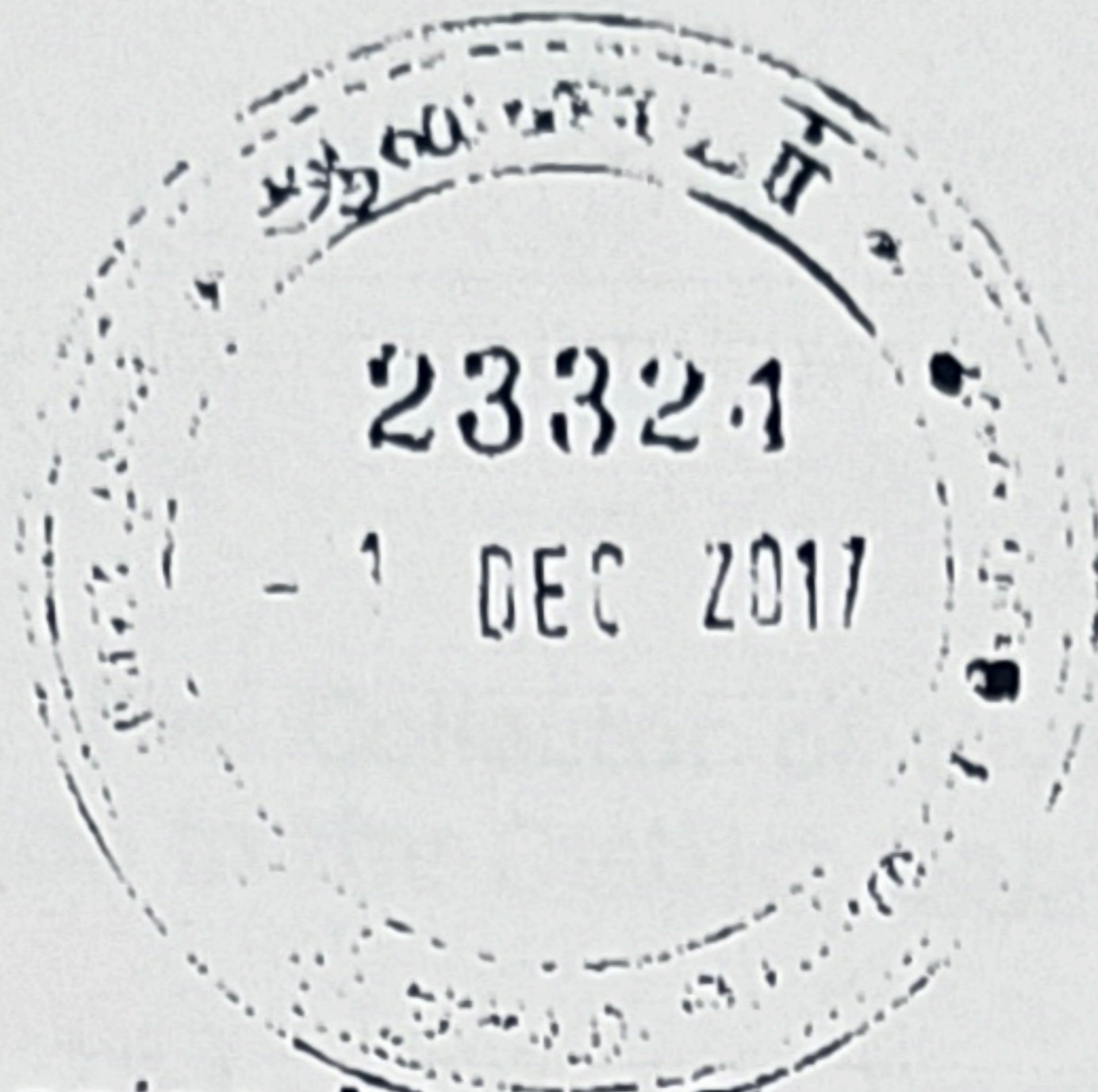
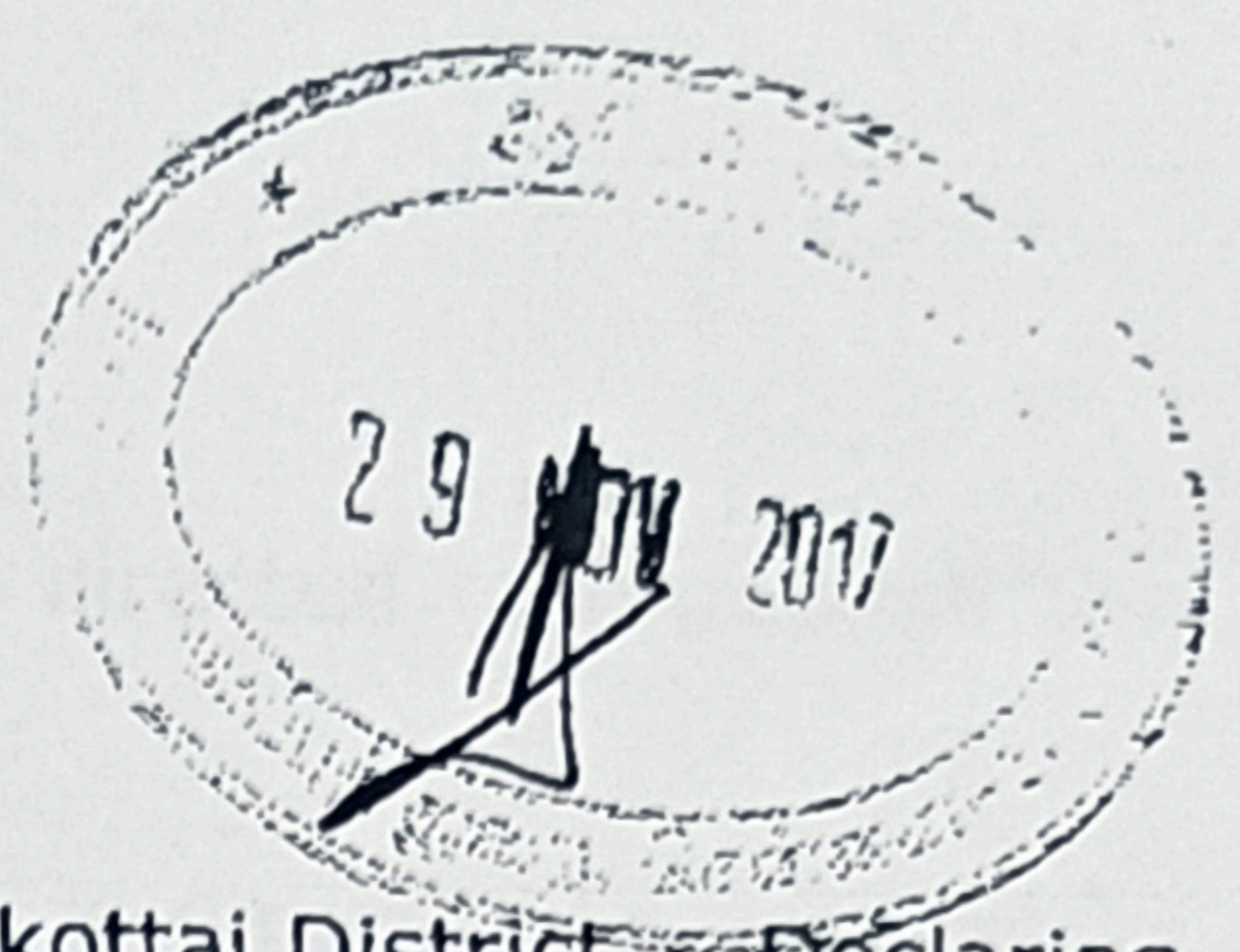

ORDER:

During the Budget session 2017-18, while moving Demand No.26, the Minister (Housing and Urban Development) made following announcement on the floor of Assembly:-

"To declare Chidambaram and Tindivanam as Composite Local Planning Areas and Keeranur and Thirukazhukundram as Single Local Planning Areas".

2. Based on the above announcement, the Commissioner of Town and Country Planning has sent the proposal for Declaring Keeranur Selection Grade Town Panchayat as a local planning area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971, (Tamil Nadu Act 35 of 1972) on the basis of resolution No.494/2015 of Keeranur selection Grade Town Panchayat, dated 24.02.2015.

3. The Government, after careful consideration of the above proposal of the Commissioner of Town and Country Planning have decided to declare Keeranur selection grade town panchayat as Keeranur local planning area under clause (b) of sub-section (1) of section 10 of the said Act. The appended Notification will be published in the Tamil Nadu Government Gazette.

4. The Collector of Sivagangai District is directed to republish the Notification in the District Gazette.

5. The Director of Translation, Chennai-9, is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Sivagangai District under intimation to the Government.

6. The Collector of Sivagangai District is directed to report to the Government, the date of republication of the Notification in the District Gazette.
